THE COMPACT CASE HACKATHON:

COME TO A CONFERENCE SESSION—LEAVE WITH A PUBLISHABLE OUTPUT

Hackathon: A sprint-like event in which participants collaborate intensively to create a useable project.

The Compact Case Hackathon challenges YOU to develop a Compact Case in a collaborative small group setting in a short time period. Session participants are given background materials (business press articles, industry reports, YouTube videos etc.) that will provide the source material for the **onsite development of a Compact Case during the session**. Using your laptops or smartphones and working in small groups, you will develop and write 2-3 learning objectives and the initial draft of a Compact Case. Case writing mentors are available for consultations with groups as needed. The final product of the session is a Compact Case and partial teaching note (at least the learning objectives for the case).

There are two sessions for the Hackathon at The CASE Association Annual Meeting held in association with the Eastern Academy of Management Meeting. The two sessions are scheduled as follows:

Thursday, May 20—9:00 am-12:00pm—Part I: The Compact Case Hackathon (Writing the Compact Case)

Friday, May 21—9:00am-12:00pm—Part II: The Compact Case Hackathon (Roundtable & completing the Teaching Note)

Both sessions will be conducted virtually via Zoom. Zoom credentials are provided to registered conference participants.

Part 1: Session on Thursday, May 20

The Compact Case Hackathon begins with a short case writing presentation focusing on the unique aspects of Compact Cases. Participants then spend the bulk of the session "hacking" their cases, starting first with the development of learning objectives and then writing the initial draft of the case itself. You bring the creativity and the energy—I bring the case ideas. Together we will form small groups and spend our morning writing!

Part II: Session on Friday, May 21

The Hackathon concludes with the presentation of cases in a roundtable format and provision of constructive feedback for developing the cases further for journal submission. We will also cover the next steps to getting your cases published. All cases developed in a Compact Case Hackathon that are subsequently accepted for publication in *TCJ* will be considered for recognition (and a prize!) as the "Best Compact Case." *TCJ* has published five cases developed in Case Hackathons!

While we encourage you to attend both sessions, you are welcome to attend which ever session you can. If you have to make a choice—come on Thursday and write with us!

Best Case Awards and Recognitions

The Emerald Best Case Award sponsored by Emerald Publishing Group honors the best case as published in *The CASE Journal*. Members of the journal's editorial board select the winner from nominations made by the Editor-in-Chief. Both the case itself and the instructor's manual are reviewed in the award selection process. The winning case author receives a check for \$1,000 provided by the Emerald Publishing Group. The award is presented annually at The CASE Association's annual meeting in May. We are pleased to recognize the finalists for the Emerald Best Case Award for 2020. This award goes to the best case as published in the journal during the previous year. Our process involves the nomination of six to eight cases that are then reviewed by the Awards Committee. The three finalists were:

Outstanding Reviewers for The CASE Journal

Reviewers make important contributions to the quality of the journal through their rigorous and timely reviews. We are pleased to honor the top reviewers for *The CASE Journal* for 2020. Two criteria were used to select the top reviewers from the 134 individuals who reviewed for *TCJ* in 2020—the number of cases reviewed and the average-R score. The average-R score is an indication of the quality and timeliness of the review (as assigned by the Editor-in-Chief). The reviewers were then sorted by number of reviews and average-R score to give you this listing of the most outstanding reviewers for the year. Originally we were going to stop at 10 reviewers, but there were so many reviewers with perfect or near perfect Quality scores that we decided to list the top 18 reviewers.

We are sad to report

that Debapratim Purkayastha, member of **The CASE Journal** Editorial Board, died of COVID-19 on May 7, 2021. Debapratim was to be appointed as an Associate Editor in June 2021.
